
- Automatic updates in Tridion when an asset is updated in DAM

The front-end web application pulls information from both Tridion and from the underpinning DAM. If needed, Digital Asset Management (DAM) Accelerator connects to multiple back-end systems in a single implementation. It provides full integration both in editorial and live website environments.




In addition, Digital Asset Management (DAM) Accelerator provides:
