# Shanghai United Imaging Healthcare adopts a structured approach to content

United Imaging Healthcare Co., Ltd. worked together with SDL (now RWS) to adopt a comprehensive structured content management solution to its development of technical documents for more than 100 products.

United Imaging Healthcare develops and produces a broad portfolio of advanced medical imaging products from diagnosis to treatment.

The company's Healthcare Technical Communication Center is responsible for writing the user manuals and service manuals for all product lines. The manuals are translated into multiple languages to support the global strategy of the company.

### The challenge

For many years, the group created its content using an 'unstructured' writing mode, storing its content in files that did not follow a pre-defined data model. In addition, all documents were managed and released using highly manual processes.

This resulted in a number of issues:

- Duplicated effort in writing, reviewing and maintaining the same content
- Inconsistent content descriptions
- · Resubmission of translations

In combination, these problems lead to unnecessary overhead costs, working inefficiently.

To address these issues, United Imaging Healthcare wanted to make a move from an unstructured writing model to a structured manual development model.
