NOTES TO THE PROXY FORM:

PROXY FORM

1. As a member of the Company you are entitled to appoint a proxy to exercise all or any of your rights to attend, speak and vote on their behalf at the meeting of the Company. You can only appoint a proxy using the procedures set out in these notes.
