The Board has direct oversight of climate-related issues, and it agrees on our position and commitments on climate change. Environmental performance is reviewed by our Board sixmonthly and is audited and reported annually against our objectives and targets.

In accordance with our key principle of improving the environmental sustainability of our business, RWS is committed to:

- Raising awareness both within RWS and externally with our stakeholders, promoting a culture of environmental responsibility
- Developing a carbon reduction plan using a science-based target aligned with the Science Based Target initiative (SBTi) criteria and submitting the plan to the SBTi for official validation
- Reducing its carbon emissions in line with science-based targets, using FY22 as a baseline and to be net zero by 2050
- Reducing resource consumption and improving efficiencies in the use of natural resources and energy
